

Minutes Parish meeting held on Wednesday 12th November 2025 at Pavilion.

- 3. Minutes of 8th October 2025** – Accepted and signed as record AB and JM
- 4. Matters Arising:**
 - **Highways Update/Traffic Calming/Speeding/Wynding/Ingram Road** – AB – AB advised that NCC have confirmed planned traffic calming works will be carried out early in the new year, weather permitting, also NCC advised the extension of DYs on Lucker Road will now go to consultation. Richard McKenzie will visit the village in the next few weeks to complete survey for the car parks direction signs and the renaming of Links Road car park to 'Bamburgh Village Car Park' will go ahead early in the new year.
 - **Wheelchair Access to Beach (Beach Access to NE)** – KD – KD confirmed still really busy and have been successfully trialling a new wheelchair, the donation box has now been emptied and was extremely pleased to report £1k has now been given to BANE.
 - **Play Park** – JM – AB has now installed mesh and seeded perimeter path, JM to discuss with Playscheme and arrange the annual safety report and any necessary repairs to coincide.
- 5. Public Questions** – Can DYs be applied to the entrance to Islestone Court – agreed to ask NCC whether this is possible.

- **Other Business –**
- Lights on the green not working – JMC confirmed electrician recently repaired the lights sensor, but this has now been damaged again! The sensor will be repaired again this week, and we will monitor the situation.
- JMC confirmed request sent to local services regarding cover to storage area and clearing of fallen leaves in village – still awaiting response, will follow up.
- SA queried why white lines have not been applied to new section of road to Glororum crossroads – JMC to follow up with GRT.
- AB advised that there may be the possibility of opening a field on the Wynding for car park trial for one month, will update further.
- JM will once again look to assessing village parking solutions, with the assistance of a sub-committee.
