

**Minutes Parish meeting held on Wednesday 4th February 2025 at Pavilion.**

- 1. Apologies** –Guy Renner-Thompson (GRT)
- 2. Declaration of interest** – None
- 3. Minutes of 17<sup>th</sup> December 2025** – Accepted and signed as record AB and JM
- 4. Matters Arising:**
  - **Highways Update/Traffic Calming/Speeding/Wynding/Ingram Road** – AB - GRT had advised that NCC have confirmed that the planned Traffic Calming measures are undergoing the final Road Safety Audit, they will advise of dates as soon as this is complete.
  - **Wheelchair Access to Beach (Beach Access to NE)** – KD – KD route to beach continually being monitored. KD looking at raising funds to purchase a wheelchair that is able to safely travel through water. At the recent memorial service of village resident Martin Chivers, all proceeds of a collection was kindly passed to the Bamburgh Wheelchairs fund, for which all are extremely grateful.
  - **Play Park** – JM – JM advised Playscheme will carry out annual safety report and remedial play park inspection on 16<sup>th</sup> February.
- 5. Public Questions** – Resident queried legality of on street parking in the village of Camper Vans, NCC had been asked at a previous meeting for assistance with solutions, JMC to follow up with NCC and GRT who was previously checking Traffic Regulation Order. Resident queried reason for wood stacked in field on The Wynding, this consists of old tree roots/branches, burning of this is permitted.
- 6. Financial Statement** – JMC update on the financial statement, bank statement @ 04/02/26 = Current A/C – £376.95, Saver A/C – £38,669.21 (includes £7,357.69 lights fund)
- 7. Planning Application** – **26/00084/FUL and 26/00085/LBC** – Village House 11 Front Street Bamburgh Northumberland NE69 7BW – No Objections
- 8. Planning Application** – **26/00235/FUL and 26/00236/LBC** – Wynding House 4 The Wynding Bamburgh Northumberland NE69 7DB – No Objections
- 9. The Glororum path** – AB – AB awaiting the permissive path to be created.
- 10. Lights on The Green** – AB – Lights have once again been damaged and still not working. AB will contact electrician to resolve.
- 11. Snow Warden scheme** – NT – advised we now have 5 (possibly 6) snow wardens, all 4 grit bins have been refilled, which can be added through 'Fix My Street' for any future snow storms. JMC to follow up with purchase of a further grit bin. BPC purchased a snow plough and will also follow up with NCC to try and have a roof erected on the Store to protect equipment.
